- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proporation to the percentage of completion of the project.
- 6. That the amounts from the separate acount shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proporation to the percentage of completion of the project.
- 7. That I/promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verifed during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That I/promoter have received all statuatory approvals and permits from the competent authorities for commencement of the proposed real estate project.
- 9. That I /promoter shall take all the pending approvals on time, from the competent authorities.
- 10. That I/promoter have/ has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 11. That I/promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be on any grounds.
