Schedule 1

TERMS AND CONDITONS

The registration for the Real Estate Project **ASSET TAURUS IDENTITY** located at **Village: ATTIPRA, Taluk: THIRUVANANTHAPRUAM, District: Thiruvananthapuram, Pin: 695581** and promoted by **ASSET HOMES PRIVATE LIMITED** and bearing registration number with Kerala Real Estate Regulatory Authority as **K-RERA/PRJ/TVM/057/2023** and valid till **30/10/2027** is granted subject to the following terms and conditions:

1. The promoter shall enter into an agreement for sale with the allottees as provided in 'Annexure A' of the rules;
2. The promoter shall execute and register a conveyance deed in favour of the allottee or the association of the allottees, as the case may be, of the apartment or the common areas as per Section 17 of the Act;
3. The promoter shall deposit seventy percent of the amounts realized from the allottees by the promoter in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost, and is to be used only for that purpose as per sub-clause (D) of clause (I) of sub-section (2) of Section 4 of the Act;
4. The registration shall be valid up to **30/10/2027** unless renewed by the Real Estate Regulatory Authority in accordance with Rule 7 read with Section 6 of the Act;
5. This registration shall be valid till the date of expiry of registration, subject to the condition that the validity of permit is extended till that date. Further, on expiry of the permit, this registration shall stand automatically repealed.
6. The promoter shall comply with the provisions of the Act and the Rules and Regulations made there under;
7. The promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.
8. Registration is granted subject to the following conditions. (1) Agreement for Lease executing with the allottees shall be in conformity with the provisions of the Real Estate (Regulation and Development) Act & Kerala Real Estate (Regulation and Development) rules. (2) The promoter shall upload Copy of the Registered Joint Development Agreement with M/s Dragonstone Realty Pvt Ltd before entering into an agreement for lease with the allottees. (3) Registered Lease agreement between M/s Dragonstone Realty Pvt Ltd and Technopark shall be uploaded before entering into an agreement for lease with the allottees. (4) Conditions in the building permit shall be satisfied.
