The registration for the Real Estate Project OMG VIVANTE VILLAS located at CHANDRA NAGAR, PALAKKAD-678007 and promoted OMG PROPERTIES PRIVATE LIMITED and bearing registration number with Kerala Real Estate Regulatory Authority as K-RERA/PRJ/184/2020 and valid till 24/03/2023 is granted subject to the following terms and conditions:

- 1. The promoter shall enter into an agreement for sale with the allottees as provided in 'Annexure A' of the
