Schedule 1

TERMS AND CONDITONS

The registration for the Real Estate Project <u>MELONWOOD REJOYZ</u> located Near <u>BHARATHMATHA COLLEGE-</u> <u>KOLLAMKUDIMUGAL ROAD THRIKKAKARA, COCHIN -682021</u> and promoted by <u>MELONWOOD HOMES PRIVATE</u> <u>LIMITED</u> and bearing registration number with Kerala Real Estate Regulatory Authority as <u>K-RERA/PRJ/151/2020</u> and valid till <u>30/11/2023</u> is granted subject to the following terms and conditions:

- 1. The promoter shall enter into an agreement for sale with the allottees as provided in 'Annexure A' of the rules;
- The promoter shall execute and register a conveyance deed in favour of the allottee or the association of the allottees, as the case may be, of the apartment or the common areas as per Section 17 of the Act;
- The promoter shall deposit seventy percent of the amounts realized from the allottees by the promoter in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost, and is to be used only for that purpose as per sub-clause (D) of clause (I) of sub-section (2) of Section 4 of the Act;
- 4. The registration shall be valid for a period commencing from <u>13/08/2020</u> and ending with <u>30/11/2023</u> unless renewed by the Real Estate Regulatory Authority in accordance with Rule 7 read with Section 6 of the Act;
- 5. This registration shall be valid till the date of expiry of registration, subject to the condition that the validity of permit is extended till that date. Further, on expiry of the permit, this registration shall stand automatically repealed.
- 6. The promoter shall comply with the provisions of the Act and the Rules and Regulations made there under;
- The promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.
