KERALA REAL ESTATE REGULATORY AUTHORITY (GENERAL) (FIRST AMENDMENT) REGULATIONS, 2022

1. Short title, Commencement.-(1) These Regulations may be called the Kerala Real Estate Regulatory Authority (General) (First Amendment) Regulations, 2022.

(2) These regulations shall be applicable to the whole State of Kerala.

(3) These Regulations shall come into force as on the date of its Notification in the official Gazette.

2. Amendment to the Regulations.-In the Kerala Real Estate Regulatory Authority (General) Regulations, 2020,

(i) In Regulation 5(4), for the words "certificate from an Architect" the words "declaration" shall be substituted.

(ii) The existing Form No. 6 shall be substituted by the following,-

Explanatory Note

(This does not form part of the notification, but intended to achieve its general purport.)

The existing certificate in Form 6 annexed with the Kerala Real Estate Regulatory Authority (General) Regulations, 2020 is the one obtained from the Architect which ensures only the structural completion of the building. But the promoter is the person who is liable to complete the whole project and handover the same to its allottees as promised to them as per the terms of the agreement executed with the allottees along with all the statutory approvals/sanctions. In order to achieve the above purpose the existing Form 6 from the Architect being replaced by the confirmation from the Promoter with respect to completion of the whole project with the provisions for obtaining occupancy certificate and ensuring the completion of all statutory requirements.

This notification is intended to achieve the above object.
