## ORDER

1. Shri. P Gopalakrishnan, applied for the registration of the plot development project '**Vasudha**' located at Kanayannur in Ernakulam District under Section 3 of the Real Estate (Regulation and Development) Act, 2016 before this Authority. The Authority granted registration to the project on 05.11.2024 vide reference number K-RERA/PRJ/ERN/221/2024, under Section 5 of the Act, 2016. The date of completion of the project is 30.11.2028.
2. The promoter has submitted a request dated 27.05.2025 seeking deregistration of the project, along with a duly sworn affidavit. In the affidavit, he stated that the entire property has been divided and demarcated into ten (10) housing plots and that no further development work has been carried out thereafter. He affirmed that none of the plots have been sold, no agreements for sale have been executed, and no amount has been collected from any prospective buyers or allottees. He further declared that the project is not a joint venture and that, due to his ill health, he is unable to continue with the project, which presently remains at a standstill. The promoter has also produced the cancellation certificates of the Master Collection Account and the Separate Account designated for the project, and has submitted the development permit cancellation certificate issued by the Amballoor Grama Panchayath, Ernakulam District.

3. On the basis of the request and the affidavit filed by the promoter, the Authority hereby decides to allow the cancellation of the project '**Vasudha**', which was registered before the Authority vide reference No. **K-RERA/PRJ/ERN/221/02024** dated 05.11.2024. Accordingly, the webpage of the project in the portal of the Authority shall be indicated with Abandoned / De- Registered project. The promoter is also debarred permanently from accessing the webpage of this project.




